Dear Prof. Janssens and Board Members:

Request to the President and Board Members of the European Cancer Prevention Organisation

We wish to bring a serious matter to your attention and to request that you take action to address it.

Dr. Carlo La Vecchia is an <u>Associate Editor</u> of the European Journal of Cancer Prevention, the official journal of your organisation, the <u>European Cancer Prevention Organisation</u> (ECPO). Dr. La Vecchia is also a member of the ECPO <u>International Advisory Board</u>.

Dr. La Vecchia is a share-holder and a <u>Director of Research</u> of the International Prevention Research Institute (IPRI), a private, for-profit consulting company formed in 2009.

In 2011, Dr. La Vecchia and Dr. Paolo Boffetta, Vice-President in charge of Research of IPRI, were paid by the Italian Montefibre company to testify in a court case in which the company was charged with criminal negligence in regard to the deaths of a number of its workers from mesothelioma, caused by exposure to asbestos. Drs. La Vecchia and Boffetta testified in support of the company's argument that if workers had been exposed to asbestos in the 1950s and 1960s, then it did not matter if they were subsequently exposed to asbestos. According to Drs. La Vecchia and Boffetta, repeated, subsequent exposure to asbestos does not cause additional harm to health. Therefore, since the managers from the 1950s and 1960s had already died, the more recent company managers would be given impunity for having continued to expose the workers to asbestos over the ensuing decades.

While an appeal of the court case was pending, Drs. La Vecchia and Boffetta published an article in your journal, the European Journal of Cancer Prevention, entitled <u>Role of stopping exposure and recent exposure to asbestos in the risk of mesothelioma</u>, which put forward the same arguments they had been paid to advance in court. In their article, Drs. La Vecchia and Boffetta stated that their review of the scientific literature showed "consistent evidence that for workers occupationally exposed in the distant past, the risk of mesothelioma is not appreciably influenced by subsequent exposures. Further,

stopping exposure does not materially modify the risk of mesothelioma over subsequent decades."

The article was submitted on Wednesday, September 28, 2011 and accepted four days later on Sunday, October 2, 2011, an extremely speedy process, which suggests that serious, due diligence through peer review did not take place.

The article is contaminated by serious scientific and ethical flaws.

The "review of the scientific literature" carried out by Drs. La Vecchia and Boffetta was selectively restricted to a limited number of papers. Their so-called review carefully omitted articles in the scientific literature, which demonstrate that continued, increased exposure to asbestos does, in fact, cause additional harm to workers. IARC has shown in multiple studies that as exposures increase, risk increases.

The bias of Dr. La Vecchia's and Dr. Boffetta's article is highlighted by epidemiologist, Dr. Dario Mirabelli, who points out that they "cite our most recent <u>article</u>¹ on mortality among workers in the Eternit plant in Casale Monferrato, but they do not cite our main result, which is that mesothelioma mortality is directly proportional to the duration of exposure to asbestos."²

The article by Drs. La Vecchia and Boffetta serves the interests of the company that had hired them. It goes against the goals that ECPO claims to pursue, namely that of preventing cancer and helping cancer victims and their families. Contrary to the goals of ECPO, the court testimony and the article duplicating the court testimony of Dr. La Vecchia serve to deny justice to asbestos victims and to increase cancer risks for workers by endorsing continued exposure to asbestos as non-harmful. Dr. La Vecchia's testimony and article also serve to promote impunity for companies that have subjected their workers to repeated and continued exposure to asbestos, which acts as an incentive for corporate managers and companies to continue doing so.

A further example of ethical misconduct by Drs. La Vecchia and Boffetta is the fact that they stated in the article that they had "no conflicts of interest". This is a false statement. They omitted to declare the fact that they had been hired and paid by the Montefibre company to put forward this exact argument in court.

The European Journal of Cancer Prevention states the following:

Dr. La Vecchia's statement that he had no conflicts of interest violates the conflicts of interest requirement of the official journal of the ECPO.

It is, in our opinion, completely unacceptable that an Associate Editor of a scientific journal can be permitted to violate the ethical standards he is supposed to uphold. If the Associate Editor does not respect the conflict of interest requirements of his own journal, this sends a strong message that the journal's conflicts of interest standards are not to be taken seriously.

The article by Dr. La Vecchia contains additional improprieties. The article states:

"This work was conducted with the contribution of the Italian Association for Cancer Research (AIRC), project No. 10068."

This is false. AIRC has confirmed that they provided no funding for this work.³ Thus, the good reputation of AIRC has been falsely used to lend credibility to the article. This was certainly advantageous to the interests of the Montefibre company in its recent and ongoing court case claiming impunity for the deaths of its workers. It is extremely disturbing that the credibility of an organisation that works to prevent cancer and to help cancer victims was falsely used to lend legitimacy to an article that serves to deny justice to cancer victims and to increase risks of cancer harm.

We attach an in-depth investigative report of December 18, 2013 by Le Monde's science journalist, Stéphane Foucart, *Epidémiologie: des liaisons dangereuses. Amiante: une curieuse expertise.* The report documents many examples of how Dr. La Vecchia's consulting company has published articles, financed by toxic industries, which come up with distorted conclusions, favourable to the industry that financed the article, and which deny harm caused by substances that have been recognized by IARC and the reputable scientific community as known carcinogens, such as diesel fumes.

We believe that Dr. La Vecchia's conduct, as documented above, is incompatible with holding the position of Associate Editor of the European Cancer Prevention Organisation's official European Journal of Cancer Prevention and is incompatible with being a member of your organisation's International Advisory Board.

- We therefore request that you terminate Dr. La Vecchia's position as Associate Editor of your journal and his position as a member of your International Advisory Board.
- We furthermore urge you to publish a correction of the inaccurate information that was put forward in the article by Drs. La Vecchia and Boffetta.
