Dear Prime Minister Trudeau:

First of all, we congratulate you on your election as Prime Minister of Canada. We wish you and your government every success in providing sound leadership and policy to meet the many challenges facing Canada and the world.

We applaud the Liberal Party of Canada for having, in 2009, taken a stand opposing the use and sale of asbestos.

The pro-asbestos policy of the previous Conservative government ignored the scientific evidence and caused harm to countless people in Canada and around the world. It brought enormous international condemnation of Canada as a threat to science, public health and international collaboration.

We understand that you and your government have many extremely serious issues to address. However, we call on you to announce in your government's Speech from the Throne at the opening of Parliament in December that your government will introduce legislation to ban asbestos, as over 50 countries have already done.

Asbestos continues to be the biggest occupational killer of Canadian workers, yet the previous Canadian government rejected appeals from health experts to ban asbestos and allowed the continuing import of millions of dollars' worth of asbestos-containing goods into Canada each year, thus exposing increased numbers of Canadians to harm.

By announcing your government's intention to ban asbestos, you will send a clear message nationally and internationally that the new government of Canada will act with integrity and:

- Will base public policy on scientific evidence
- Will act to protect public health

- Will play a positive leadership role on the international scene in support of the World Health Organization's call to end all use of asbestos
- Will support the listing of chrysotile asbestos as a hazardous substance under the UN Rotterdam Convention

We have much expertise on the scientific level, the practical level and the human level with regard to protecting populations from asbestos harm and providing support and justice for those who have already been harmed. We offer to you our full and sincere collaboration.

We look forward to opportunities to work with your government to help end the terrible and unnecessary tragedy that asbestos has caused in Canada and around the world.

We strongly hope that the Speech from the Throne will include a commitment by your government to introduce legislation to ban asbestos.
